करणे तसेच संशोधन करणे हे संघाचे ध्येय आहे. मराठी शिक्षकांच्या वर्जदार अध्यापनासाठी ज्ञान प्रसार आणि संशोधन या संदर्भात विविध उपक्रम राबविले जातात. त्यानुसार विविध विषयांवर राष्ट्रीय चर्चासत्र, परिसंवाद कार्यशाळेचे आयोजन केले जाते. विविध महाविद्यालयातील चर्चासत्रे तसेच कार्यशाळांमध्ये बौद्धिक सहयोगी होऊन सहकार्य केले जाते. विद्यार्थ्यांमध्ये मराठी भाषेचे आणि साहित्याचे विकसन करण्याच्या दृष्टीने निबंधलेखन, कथालेखन, काव्यलेखन, कथाकथन, काव्यवाचन अशा विविध स्पर्धांचे आयोजन केले जाते. तसेच मराठी प्राध्यापकांच्या शोधनिबंधांना पारितोषिक, ललित व ललितेतर ग्रंथांना पारितोषिक दिले जाते. संघामार्फत 'शिविम संशोधन पत्रिका' हे विद्वत्प्रमाणित त्रैमासिक प्रसिद्ध केले जाते. त्याचा ISSN No.2319-6025 असून शिवाजी विद्यापीठ आणि यु.जी.सी. मान्यताप्राप्त यादीमध्ये पत्रिकेचा समावेश झालेला आहे.

५. स्पर्धा परीक्षा मार्गदर्शन केंद्रासाठी सहकार्य करणे.
६. व्यक्तिमत्त्व विकास प्रकल्प, कौशल्य विकास प्रकल्प राबविणे.
७. दरवर्षी कोल्हापूर, सांगली, सातारा या शिवाजी विद्यापीठाच्या कार्यक्षेत्रामध्ये संघाचे वार्षिक एक/दोन दिवसांचे अधिवेशन विविध साहित्यिक विषयांवर घेणे. सदर अधिवेशनात प्राध्यापकांच्या शैक्षणिक तसेच विषयांच्या समस्यांवर चर्चा करणे.
८. सर्जनशील लेखन, उपयोजित मराठी लेखन प्रकल्प राबविणे.
९. मोडी लिपी, मुद्रितशोधन, पत्रकारिता इत्यादी अभ्यासक्रमांचे आयोजन करणे.
१०. ग्रंथ प्रकाशित करण्यासाठी सहकार्य करणे. संघाचे प्रकाशन व चर्चा घडवून आणणे.



११. मराठी भाषा, साहित्य आणि संस्कृती या संबंधाने येणाऱ्या समस्या व अडचणी विद्यापीठ, शासन आणि विद्यापीठ अनुदान आयोग, दिल्ली यांना यासंदर्भात सूचना-पत्रव्यवहार करणे.

एकमेकांना सहाय्य करण्याची प्रस्तावित माध्यमे

१. परस्पर हिताच्या शैक्षणिक बाबींमध्ये तसेच प्रशिक्षणामध्ये सहकार्य करणे.
२. विविध उपक्रमांचे आयोजन करण्यासाठी परस्परांशी सहकार्य करणे.
३. उपलब्ध साधनसामुग्रीनुसार या संस्थाकडून एक निश्चित योजना तयार करणे.
४. त्रैमासिकाद्वारे साहित्य, विचार यांची देवाणघेवाण करणे.
५. दरवर्षी संघाचे अधिवेशन विविध कॉलेजवर आयोजित करून विचारविनीमय करणे.
६. शासन, साहित्य अकादमी, मराठी साहित्य व संस्कृती महामंडळ, राज्य मराठी विकास संस्था यांचे उपक्रम सौजन्याने राबविणे.

अटी

२. परस्पर सामंजस्य करारातील उदाहरणांचे नुतनीकरण करणे आणि परस्परांच्या लेखी करारांची कोणत्याही क्षणी समाप्ती केली जाऊ शकते. साठ दिवसांच्या पूर्व लेखी सूचनेनुसार दोन्हीपैकी कोणत्याही संस्थेला करार संपुष्टात आणता येईल.
३. कोणत्याही महाविद्यालयांस प्रवास व भोजन भत्ता देणे बंधनकारक नाही.

Duration of MoU:



Both institutions will designate persons who have responsibility for co-ordination and implementation of this agreement.


